## LICENSING BOARD MINUTES April 16, 2019

Meeting called to order. Present were, Chairman Phil Antonelli, Board Member Brian McCarthy, Board Member Phil Arloro, Detective Michael Lavey

1. Everett Bar & Grill - Daniel Surien & Mario Navarro were called up for a police report for a minor that was drinking in Everett Bar & Grill. The Chairman read the report which when the minor spoke with the police officer he told him that he was drinking inside the bar. Daniel said he was not aware of him being in the bar but at this time does not have cameras to say for sure that he was not in there. The Board advised Daniel that he should install the cameras soon. Daniel says that he will be placing 2 on the bar and 1 on the street by the front door and the cameras would also help with staff training. The Board will send a letter out stating that they will be placed on probation for the remainder of the year.
2. Texas Road House, Attorney Andrew Upton, appeared for a change in Corporates Officers at the Corporate Headquarters. No other aspects will change. The Board votes and approves the change.

3. LaFinca appeared for a police report for a female that that was in a car accident and also told the police that she was served 5 beer - 3 Coronas and 2 Heinken within a half hour. Rich states that he was not working that night and that his sister was there. He is not sure if she was or was not there, but if she says that she was she probably was. Phil Arloro says that he has gone by the bar and says that the music is very loud there and Rich should

have a conversation with his sister about over serving patrons. The Chairman says that he has not been up in over a year, a letter will be sent out and they will be placed on probation for the remainder of the year.

4. Tres Gatos did not come in and will appear on April 22, 2019
5. Winners Sports Bar and Karma Lounge were called in for trash blocking the back egress door. Daniel Cordon, Tony Portillo and Varun Punj. The Chairman reviews pictures that show trash bags in the back of the building blocking the second means of egress and large grease containers under the porch. This is a fire hazard. Deputy Chief Dattoli was not able to attend the meeting but was on speaker phone and stated that until the back egress is clear and a trash contractor is hire for daily pick-ups they are to close at 11:00 pm every night. They must produce a contract to the License Board. Also the Chairman requested receipts or paperwork from Tony for the grease container pick-up. Varun says that he will call a company on Wednesday and set a contract up. Also the dishwasher has been fixed which will eliminate some of the trash because they will not have plastic cups.

The Chairman also tell Varun that if he has a 7 day license he has to be open 7 days, if he is going to be closed on Monday and Tuesday then his license needs to reflect that and a change of hours has to be done.

Winners Sport Bar business plan will be placed on hold to be review at a later date.
