Health Department Nurses Update and Director's Report

- Covid daily updates are posted on the City of Everett website and social media daily.
- We are still offering covid testing 6 days a week at the Rec center. 47 Elm Street Mon-Thurs 7am-1 pm and 2pm-7pm, and Fri & Sat 12pm – 6pm. The testing has been extended until June 30th.
- We are continuing Vaccine clinics on Saturdays at Pope John. Appointments are required. March 27th will be second dose appointments.
- As the phases roll out we continue to request vaccines from the state. We are currently getting 400 doses per week.
- Mayor DeMaria is pushing for the city to get as much vaccine as possible as he wants it to be available to anyone that wants it as they become eligible.
- Vaccine distribution phases are determined by the state health department and the department of public health.
