Concerns has been raised to the Commission as well as among Commission members as to the ability of Commission Chair/City Clerk Sergio Cornelio to fulfill his duties for the September 21st preliminary election. This concern was based on allegations made by City Clerk Cornelio against Mayor DeMaria concerning a personal business transaction.

Commissioner Cheever advised the members that advice had been sought from the Secretary of State's Office, the Massachusetts Ethics Office, and the Everett City Solicitor's Office. All three advised that the Commission could only request that City Clerk Cornelio recuse himself from overseeing the preliminary election. The Commission does not have the authority to relieve him of those responsibilities.

Commissioner McCarthy explained that the Commission did not take this action lightly and was acting only to fulfill the responsibility of protecting the integrity of the election.

A motion was made by Commissioner Cheever, seconded by Commissioner Pindea, that Commissioner McCarthy send a communication to Chairperson Cornelio respectfully requesting that he recuse himself from his election duties.
