Background

City Hall, located at 484 Broadway, is a four story building that houses the Mayor's Office, Registrar of Voters, Retirement Office, Human Resources, Council Chambers, City Clerk's Office, Collector's Office, the Health Department, Everett Community TV, Women, Infants and Children Office, Code Enforcement Office, Engineering Office, Inspectional Services, Assessor's Office, Auditor, Constituent Services and Building Department among others.

The levels are connected by two sets of stairs and one elevator. There are two entrances to level 1 and one entrance to the lower level. Two out of three have only minor accessibility issues. There is a parking lot on the northwest side that has only minor accessibility issues.

Key Accessibility Issues

Entrance and Exits

Two sets of double doors at the main entrance lack leaves that provide a clear width of 32 inches. There is some damage to the accessible entrance threshold on the Lower Level. Clear floor space is not provided at the automatic door opener at the entrance from the parking lot.

Interior Routes

Although a ramp is provided to an intermediate tier of seating in the Council Chambers, no accessible route is provided to the upper tier. Similarly, there is no accessible route to the TV studio stage due to a seven-inch step.

Doors

Doors throughout the building lack hardware that is operable with a closed fist. All toilet room doors lack maneuvering clearance on the pull side of the door. Doors to the Hearing Room lack maneuvering clearance.

Stairs

Stairs throughout the building lack handrails with a compliant cross section.

Elevator

Elevator call buttons are beyond reach range at all levels. Hoistway signage with a tactile star is not provided at either elevator door jambs on level 1. Tactile stars are not provided at the main entry level on the hoistway or on the control panel within the car. Audible car position indicators were not working on the day of survey. The elevator telephone is located beyond the reach range.

Service Counters

Service counters throughout the building are located higher than 36 inches above the floor.

Assistive Listening Systems

Assistive listening systems are not provided in the Council Chambers or the Hearing Room.

Toilet Rooms

A men's and a women's multi-user toilet room is located on the Lower Level, Level 2, and Level 3. There are no wheelchair accessible toilet compartments or urinals provided in the toilet rooms on Level 2 or in the men's toilet room on the Lower Level. Audible and visible alarms are not provided in toilet rooms. Additional concerns are the lack of pipe protection at lavatories, mirrors located higher than 40 inches above the floor, dispensers located beyond the reach range, accessible compartments with incorrect door swings, urinals located higher than 17" above the floor, and protruding objects. Many toilet rooms are kept locked and require twisting. Visitors must pick up keys at level 1 and travel to the Lower Level or Level 2 to use the toilet room.

Drinking Fountains

No drinking fountains are at an accessible height with toe and knee clearance for seated users.

Additional Accessibility Issues

- There is a level change greater than ¼ inch deep due to a missing tree grate by the main entrance.
- One van and one car accessible space are required in the lot at the rear of the building. They are provided but have minor issues including signage.
- Some curb ramps lack detectable warnings and noncompliant landings.
- Clear floor space is not provided alongside a bench near Broadway and Church Street due to trash barrel placement.
- There is noncompliant egress and designation signage throughout the building. The International Symbol of Accessibility is not provided at the parking lot entrance or at any toilet rooms in the building.
- Work surfaces in a few locations lack toe clearance.
- There is a lack of visible fire alarms throughout the building.
