#### Legislative Affairs & Election Committee February 14, 2022

#### COMMITTEE REPORT

The Committee on Legislative Affairs & Elections met on Monday, February 14, 2022 at 6pm in the City Council Chambers.

The meeting was recorded by ECTV and can be viewed on the City of Everett website.

Members present were Councilor Michael Marchese, presiding, Councilors Alfred Lattanzi, Stephanie Smith and Anthony DiPierro.

The Committee considered an Ordinance offered by Councilor Stephanie Martins: An Ordinance establishing paid family medical leave for municipal employees in the City of Everett.

Mayor's Chief of Staff Erin Deveney, Human Resource Director Justin Shrader, Chief Financial Officer Eric Demas and Councilor Stephanie Martins, the Sponsor were also present.

Councilor Martins provided the Committee with a packet of information relative to the acceptance of MGL 157M Section 10, worker eligibility, contributions as well as copy of the City of Boston Family Medical Leave program. She stated that she had spoken to Mr. Shrader and found that the initial cost for the program would be approximately \$800,000. Councilor DiPierro invited Mr. Shrader to discuss the information he had compiled on the program. Mr. Shrader stated that this was an all-in program in which the Cities 1500 employees would have to make weekly contributions of approximately \$3.30. He provided the Committee with a cost breakdown on what employees could eventually receive through the program. Councilor Smith inquired to what happens to any unspent money in the fund and Mr. Shrader explained that it would remain in the fund. Councilor DiPierro asked Mr. Demas what the impact of the initial \$800,000 would be to the tax rate and Mr. Demas indicated it could be .05%. Councilor Martins suggested that the City invest in its employees as it does with streets, sidewalks, etc.. Councilor Martins requested that the Committee amend to replace her agenda item with an Order: That the City Council of the City of Everett adopt MGL 157M Section 10 to opt-in to provide Paid Family Medical Leave for its municipal employees. Councilor Smith announced that she fully supports as a Mother.

The Committee voted: to report back to the City Council with a favorable recommendation to amend by deleting Councilor Martins proposed Ordinance and replacing it with the attached Order: That the City Council of the City of Everett adopt MGL 157M Section 10 to opt-in to provide Paid Family Medical Leave for its municipal employees.

**Chapter** FAMILY AND MEDICAL LEAVE

175M

Section 10 LOCAL ADOPTION

Section 10. A municipality, district, political subdivision or authority may adopt this chapter upon a majority vote of the local legislative body or the governing body. For the purposes of this section, a vote of the legislative body shall take place in a city by a vote of the city council subject to its charter, in a town by a vote at town meeting, for an authority by a vote of its governing body, in a district, by a vote of the district in a district meeting and by any other political subdivision or instrumentality, by a vote of its legislative body in accordance with its charter or enabling act.

#### IN THE YEAR TWO THOUSAND AND TWENTY-TWO

### AN ORDINANCE REDEFINING THE MAYOR'S ANNUAL LONGEVITY BONUS PAYMENT

Whereas: The interpretation of the current ordinance governing the mayor's annual longevity bonus payment has come under dispute; and

Whereas: Clarification of said ordinance is necessary to bring it in line with other permanent full-time, non-union and administrative officers and employees that serving as department heads in the City of Everett

Now, therefore, by the authority granted to the City Council of the City of Everett, Massachusetts to make ordinances:

**Be it Ordained** by the City Council of the City of Everett, Massachusetts that the Revised Ordinances of the City of Everett be amended as follows:

Section 7-167 of the Revised Ordinances of the City of Everett is hereby amended by deleting the entire current text of said section and replacing it with the following new text.

- (a) On the anniversary date of employment, the city shall pay any person currently serving in the office of mayor an annual longevity payment per the schedule below:
  - 10 years of service \$800
  - 15 years of service \$1,300
  - 20 years of service \$1,700
- (b) In 2022, the first year of the implementation of this version of this section, the payment date of the current mayor's annual longevity payment shall be the business day following the effective date of this new version of the section.
