Clerk Cornelio informed President Hanlon that there were nine people signed in for public participation. President Hanlon stated that each speaker would be granted one minute of speaking time.

The first speaker was Maria Bussell of Freeman Avenue. She spoke about two words that she believes that a majority of the members of the City Council have forgotten the meaning of, trust and accountability.

After 90 seconds, President Hanlon informed the speaker that her allotted speaking time was up.

In response to an outburst from the audience, President Hanlon warned them that the Council's public participation rules were going to be followed at this meeting.

The speaker respectfully asked for time to finish her prepared remarks. President Hanlon allowed it but warned her that she was taking time from other speakers.

Councilor Marchese spoke in favor of letting the public speak.

David Fortin of Cedar Terrace was the next speaker. He spoke about the use of electronic devices at City Council meetings, the Mayor's behavior at the last regular meeting of the City Council and the Mayor's internal investigation into the racist behavior of city employees.

Councilor Smith made a motion to extend public participation for ten more minutes; it was seconded by Councilor Marchese. President Hanlon did not accept the motion.

President Hanlon declared that the public participation portion of the meeting was over and instructed Clerk Cornelio to read the next item on the agenda.

Following the Acceptance of the Minutes of the Previous Meeting, Councilor Smith repeated her motion to extend public participation by ten minutes. Councilor Marchese seconded the motion again. President Hanlon refused to recognize the motion as he stated that, by the rules, public participation cannot be extended.

Due to the inability to main order in the chamber, President Hanlon called for a ten minute recess.

Following the collective affirmative vote to confirm the appointments in items 4 thru 8, Councilor Smith rose on a Point of Personal Privilege. She stated that, as a City

Councilor, she was not in favor of how public participation was terminated. She wanted to be on the record as being in favor of letting the public speak. She wanted the public to know if they had any issues, they could e-mail or text her.

President Hanlon replied by saying that he was sorry about the way that public participation ended as well.

After the Council voted to accept Item 9, Councilor Marchese rose on a Point of Personal Privilege and stated that the people should be heard.

After trying to explain to the audience why the Council's public participation rules have not been followed so strictly at recent past meetings of the Council, President Hanlon once again called for a ten minute recess to attempt to regain order in the chamber.

After the recess, President Hanlon asked the audience to take their seats. He informed the audience that he was going to allow them to speak but they had to follow the Council's rules for public participation that had been distributed during the recess.

An audience member asked President Hanlon where the City Council Rules could be found in the City Charter. President Hanlon stated that the City Council Rules are not in the City Charter; they are in a separate document that is posted on the city web site along with all of the other city governing documents.

The next speaker was Sandy Juliano. She spoke about how the problems the Council is having with the public are of their own making, why councilors are away the their desks so often during meetings and missing votes, the mayor's longevity payment and the Council's code of conduct.

Paula Sterite of Cleveland Avenue spoke about putting a moratorium in place in the city for taking senior citizen properties for back taxes and fees, the Wellness Center and what is considered a violation of the Council's Code of Conduct.

John Popolo of Highland Avenue spoke about the Council's non-enforcement of their own rules on themselves, potholes, why, if the public can't use Councilor's names when speaking about them, are the Council and their staff allowed to use the names of members of the public when speaking about them and the Council's non-responsiveness to e-mails submitted by the public.

Janice Lark spoke about how she had applied for a part-time job at the Library and a position on the Election Commission and was overlooked for both. She did not want to believe that the reason for that was that she speaks out during Public Participation.

Snappa of Gledhill Avenue spoke out about the on-going issues at the Walgreen's Plaza in Glendale Square including vagrancy, aggressive behavior and sexual harassment. He urged the Council to take steps to eliminate the problem once and for all.

Gerly Adrien of Cumberland Street spoke about forgiveness and how her two years on the City Council being the worst work experience of her life. Darren Costa was the final name on the Public Participation sign-in sheet; However, he was not present when it was his opportunity to speak.
