Minutes of the Meeting: A motion is made by Mike Dantone to open the meeting at 6:30 PM

Motion is made by Mike Dantone to approve the minutes from January 17, 2023

1. An application was presented from Zuzu Momo, 289 Main St., for an Alteration of Premises for outdoor dining in the summer months. Mary Ellen Latas a neighbor was concerned about the rat issue and asked if the patio could be hosed down at the end of each night. The owner agreed to do so. The Building Inspector will go out to the business to check on the legality of the parking.
The Board voted to approve the Alteration of Premise 3 yays – 0 nays
2. Attorney Natasha Messias for Rumors requested to sit in on the meeting to observe.
3. Mama Santos, 386 Main St, was requested to come in as a result of an inspection from the Everett Police Dept, Everett Fire Prevention. and Everett Inspectional Service. There were no conditions that caused concern except for two bottles of tequila and vodka that were purchased at Costco. Jacqueline Cruz, the owner to dispose of the alcohol in the sink. The Board has decided to place Mama Santos on a sixty-day probation.
4. Winners Sports Bar & Grill, 355 Ferry St., Attorney Niles Welch appeared representing the owner, Tony Portillo. As a result of a complaint to 311 about overcrowding in the basement, the Everett Police Dept, Everett Fire Prevention. and Everett Inspectional Services went to the establishment on March 11, 2023, to conduct an inspection. There were multiple violations including blocked egresses, trash bags in the hallways, groups of people that appeared under 21, upstairs and downstairs, a shirtless DJ, and shirtless males in the storage area changing. Several patrons had said there was a Magic Mike night and there was a \$10.00 cover charge.

Attorney Welch states that they plan on hiring a private security company for Friday and Saturday nights to check ID's and stamp customers' hands to enter. The basement will be closed until an SOP (Standard Operating Procedures) report is given to the Board from

Attorney Welch and approved by the License Board. They will add an additional day for trash pick-up to be Monday, Wednesday, and Friday or when needed. The Chairman also adds that no one under 21 is allowed upstairs or downstairs after 8:00 PM.

5. Tres Gatos, 322-326 Chelsea St., was not able to attend and will appear on April 18, 2023.
6. Entertainment Policy tabled to April 18, 2023.

A motion was made to adjourn the meeting.
