

Public Shade Tree Hearing Notice

Public Shade Trees are protected by Massachusetts General Laws Chapter 87. The removal of a healthy public tree requires an advertised public hearing. If a tree is declared by the city to be an immediate hazard to the public, a hearing is not required.

The project involves reconstruction of Ferry Street from Revere Beach Parkway (Route 16) to the Malden City Line and Elm Street from Ferry Street to the Revere City Line. The existing traffic signal at the intersection of Ferry Street and Chelsea Street will be converted to a roundabout. Traffic signals at four locations along the Ferry Street corridor will be upgraded. The work will include full depth reconstruction and milling and overlaying the existing pavement with new hot mix asphalt. Also included in the project are new sidewalks, curbing, ADA-compliant pedestrian curb ramps, pavement markings, signs, drainage improvements, and replacement of the existing water main along Ferry Street.

The project will include the planting of approximately 90 street trees and an assortment of hedges, perennials, and annuals along Ferry Street and portions of Elm Street.

The tree(s) identified above have been posted for public inspection. Any objections to their removal must be submitted in writing to the Executive Director of Public Works, prior to or during the hearing. The mailing address for the Executive Director of Public Works is:
