- III. **Approval of minutes from last meeting:** Approved by Board
- IV. **Open Issues:** Sgt. Gaff updated on Englewood Ave. Signs has been placed and engineering is looking into painting parking spots. Resident stated there are fewer cars during the day and a "Slow Children" sign maybe needed.

 - b. Request to have something done about the speeding on Bow St, constituent would like to come up and speak about it. **Survey will be conducted**
