Regular Business:

- a. Glendale Liquor, 315 Ferry St., appeared for a police report dated June 30, 2023. The Board stated to be aware of customers that are purchasing alcohol.
- Julie Enterprises Inc. 203 Main St., appeared for a Change of Officers and Change of Stock. A motion was made by Mike Dantone and seconded by Phil Arloro to approve the change.

- e. Winners Sports Bar, 161 Ferry St., appeared for use of the basement. Currently, there is no lease for the business in place, therefore the Board did not want to take a vote for the use of the basement. In 60 days or once a lease is in place, they will come back before the Board to request the use of the basement. If Winners has any violations for underage drinking their license could be revoked. A motion was made to restore the 1st floor to normal hours with no limitations, the downstairs is not to be used until a lease is in place. The motion was seconded and approved. 3 yays 0 nays

Policies review included closing times which is 1:00 AM, last call should be at least a half hour before closing time, and special permits to be issued for outside entertainment – 6 per year. The Chief of Staff Erin Deveney will set up a public forum for all to attend.
