Monday, May 8 <sup>th</sup>	8:00 am	First day and hour to obtain nomination papers
Wednesday, July 19 <sup>th</sup>	5:00 pm	Last day and hour for candidates to submit Statement of Residency and obtain nomination papers from the Election Commission  (48 business hours prior to date for submitting papers to Election Commissioners for certification)
Friday, July 21 <sup>st</sup>	5:00 pm	Last day and hour for candidates to submit nomination papers to Election Commission for certification. (59 days - 14th day preceding deadline for it to be filed with clerk)
Friday, August 4 <sup>th</sup>	5:00 pm	Last day and hour to file certified nomination papers with city clerk  Last day and hour for candidates to finalize statement of 8 words or less
Monday, August 7 <sup>th</sup>	10:00 am	Posting of Candidates
Tuesday, August 8 <sup>th</sup>	5:00 pm	Deadline to file with Election Commission objections/withdrawals for preliminary candidates (2 business days after last day for filing nomination papers)
Thursday, August 10 <sup>th</sup>	6:00 pm	"Drawing by lot" of candidates for ballot (40th day preceding preliminary election)
Saturday, September 9 <sup>th</sup>	8:00 am – 5:00 pm	Continuous voter registration session must be held within these hours
Saturday, September 9 <sup>th</sup>	5:00 pm	Last day and hour to register to vote for preliminary election

Monday, September 18 <sup>th</sup>	12:00 pm	Last day and hour to request an Absentee Ballot to vote in person at City Hall for the Preliminary
Tuesday, September 19th	7:00 am – 8:00 pm	Preliminary Election
Monday, September 25th	5:00 pm	Last day and hour to file the following with the Election Commission <ul style="list-style-type: none"> <li>• File for recount for the Preliminary</li> <li>• Objections/Withdrawals</li> <li>• File written acceptances by write-ins or sticker candidates who won in the Preliminary</li> </ul>
Thursday, September 28th	6:00 pm	“Drawing by lot” of candidates for ballot for regular election (no later than 7th day after certification of Preliminary Election results)

Tuesday, October 31 <sup>st</sup>	5:00 pm	Last day and hour to request an Early Vote by Mail or Absentee Ballot by Mail
Monday, November 6th	12:00 pm	Last day and hour to request an Absentee Ballot to vote in person at City Hall
Tuesday, November 7th	7:00 am – 8:00 pm	Municipal Election
Friday, November 17th	5:00 pm	Last day and hour to file for recount
