Regular Business:

- A. Texas Roadhouse Holdings LLC, 31 Mystic View Road, Everett, appeared for a Transfer of the All Alcohol, General On-Premise, Restaurant License to Texas Roadhouse, Inc. A motion was made by Mike Dantone to approve the transfer and seconded by Phil Arloro. Motion passed 2 years – 0 nays
- B. Duarte Inc, D/B/A Andrea's Taqueria Everett, 293 Main St Application for a new All Alcohol Restaurant License. Attorney Mark White spoke on behalf of the applicant. The business has been in Everett for 3 years and has 16 years in the food service business. This is a family business. they have never had an alcohol license and the Board has concerns and asked for a business plan explaining how the staff will be trained and is required that all employees that will be serving alcohol be tip certified. A motion was made by Mike Dantone to table the application until December 8th. Attorney White will supply the Board with a plan prior to the meeting, seconded by Phil Arloro. Motion passed 2 years – 0 nays
- C. Ritual Coffee Bar, 629 Broadway, is requesting a One Day Permit for November 23, 2025 from 10am to 4pm. The applicant has applied for an annual alcohol but it has not been approved by the ABCC yet. This event is for a food drive for the Everett Food Pantry. A motion was made by Mike Dantone to approve the request and seconded by Phil Arloro. Motion passed 2 years – 0 nays.
Per Lt Hall a police detail will not be needed
- D. Gata's Sports Bar & Grill, 202 Ferry St, would like their hours to be extended to 1AM. They have passed their 6-month probation period and have not had any issued. They also asked to have a DJ and the Board explained they would like them to wait and come back in 6 months and if there are no issue they will be allow a DJ. A motion was made by Mike Dantone to approve the request and seconded by Phil Arloro. Motion passed 2 years – 0 nays.

- E. La Finca Bar, 37 Norwood St, would like their hours to be extended to 1 AM. They have passed their 6-month probation period and have not had any issued. A motion was made by Mike Dantone to approve the request and seconded by Phil Arloro. Motion passed 2 yeas – 0 nays.
